

## **How to ask a question at the Combined General Meeting of Getlink SE to be held on 28 April 2021**

The Combined General Meeting of Getlink SE will be broadcast live and in full on 28 April 2021 from 10:00 a.m. (CET), unless technical reasons disrupt this broadcast or make it impossible, then recorded on the 2021 General Meeting page on our website [www.getlinkgroup.com](http://www.getlinkgroup.com), which is regularly updated.

### **1. You wish to put a written question to the Board of Directors**

To ask a question to be answered by the Chairman of the Board of Directors at the General Meeting, in accordance with Article R.225-84 of the French Commercial Code, you may send your question, together with a certificate of registration either in the Getlink registered share accounts held by Société Générale Securities Services or in the bearer share accounts held by your financial intermediary, to be received no later than the end of the second business day preceding the date of the General Meeting, i.e. 26 April 2021, by:

- 1- Registered letter with acknowledgement of receipt to the Getlink head office, 3 rue la Boétie, 75008 Paris
- 2- Electronic communication to the email address [PresidentGET@getlinkgroup.com](mailto:PresidentGET@getlinkgroup.com).

### **2. You wish to participate in the Questions & Answers session during the General Meeting**

In addition to the legally regulated written question system described above, and in order to encourage shareholder dialogue, Getlink also provides an exceptional system that allows shareholders to identify themselves in advance on Votaccess in order to put a question to the Group's General Management during the meeting. As for the meetings held in person, Getlink will do its best to answer as many questions as possible in the time allotted during the Q&A session of the General Meeting.

If you wish to participate and ask a question during the General Meeting, you must register before 27 April at 3:00 pm CET (deadline) on the secure Votaccess platform, by clicking on the "To ask a question during the AGM" when you vote on this platform.

After registration, when you will log in on the day of the Meeting to follow the video broadcast of the Meeting available from the General Meeting 2021 page on [www.getlinkgroup.com](http://www.getlinkgroup.com), please make sure to fill in your email, first and last name and "shareholder ID" fields\*. You will then be connected to the meeting webcast with a "Ask a question" button at the bottom right of your screen, which will allow you to send your questions live on the platform, as the presentations are made. As for the General Meetings held in person, Getlink will do its best to answer as many questions as possible in the time allotted during the Q&A session.

*\* The information you provide in order to ask a question (name, first name, email and shareholder ID) will be communicated to the service provider in charge of the broadcasting of the General Meeting (Company Webcast - Euronext) in order to allow your identification only on the day of the General Meeting, and will be destroyed at the end of the General Meeting, in accordance with the provisions of the French law n°78-17 of 6 January 1978, and the data protection policy of Company Webcast, a subsidiary of Euronext, which can be found at <https://www.euronext.com/en/privacy-statement>.*
